1. Scope and Acceptance of the Terms

These Terms govern access to, browsing of and use of bikinilovers.it (hereinafter, the “Service”) by the user (the “User”).

Accessing or using the Service constitutes acceptance of these Terms. A User who does not agree to them must discontinue access to the Service and must not use its features.

Where a feature requires specific terms, additional notices or a separate contract, those documents shall prevail solely in respect of the matters they govern.

2. Identity of the Operator and Contact Details

The Service is operated by the entity identified in the introductory details (the “Operator”). Requests for information, assistance or reports may be sent to bklsrls@pec.it.

For communications relating to a purchase or contractual relationship, the User may also follow the procedures set out in the Terms and Conditions of Sale [\[bikinilovers.it/conditions-of-sale\]](https://bikinilovers.it/conditions-of-sale).

3. Availability, Updates and Changes to the Service

The Operator undertakes to keep the Service reasonably available, but does not guarantee that it will always be free from interruptions, errors or unavailability. The Operator may carry out maintenance, updates, corrections or changes required for security, legal compliance or the development of the Service.

Where a scheduled interruption may significantly affect essential features, the Operator will, where reasonably possible, give prior notice by email, social-media channels or WhatsApp.

4. Rules for Use of the Service

The User undertakes to use the Service lawfully, properly and in accordance with these Terms, the instructions made available and third-party rights.

Among other things, the User is prohibited from using the Service for unlawful or deceptive purposes; compromising the security, availability or integrity of the Service; introducing harmful software; bypassing technical measures; collecting data or content through unauthorised automated tools; using third-party content without a proper legal basis; impersonating third parties; or sending unsolicited communications or unlawful content.

The User is responsible for activities carried out through their credentials and for the consequences arising from improper use of the Service, to the extent permitted by applicable law.

5. Account and Credentials

To create an account, the User must provide truthful, complete and up-to-date information. Credentials are personal and must not be shared.

The User must promptly notify the Operator of any suspected unauthorised access to, or compromise of, their credentials by using info@bikinilovers.it.

The Operator may suspend or close the account in the cases set out in Section 11, without prejudice to the guarantees and protections provided by applicable law.

6. Content, Intellectual Property and Distinctive Signs

The structure of the Service, software, texts, images, graphic elements, trademarks, databases and other content are protected by applicable laws and belong to the Operator or their respective owners.

Unless authorised in writing or permitted by law, the User may not copy, modify, distribute, republish, extract, sell, license or exploit the content of the Service for purposes other than permitted personal or professional use.

Nothing in these Terms grants the User an implied licence to use trademarks, domain names, logos or other distinctive signs displayed in the Service.

7. Third-Party Links and Services

The Service may contain links, integrations or content made available by third parties. Unless expressly stated otherwise, those resources are subject to their own terms and notices.

The Operator does not control external resources and is not responsible for their content, availability, functionality or processing activities, to the fullest extent permitted by applicable law.

8. Disclaimers and Limitations of Liability

The Service and its content are provided with the features made available at the time of use. The Operator takes reasonable measures for security and proper operation, but cannot guarantee the complete absence of errors, interruptions, vulnerabilities, delays or incompatibilities.

To the fullest extent permitted by applicable law, the Operator shall not be liable for damage arising from improper use of the Service, causes not attributable to the Operator, unavailability of networks or third-party services, loss of data attributable to the User, or third-party content.

Nothing affects any liability that cannot be excluded or limited by law, including the non-waivable rights of consumers and users.

9. Personal Data, Cookies and Marketing Communications

The processing of personal data is described in the Privacy Policy available at bikinilovers.it/privacy-policy. The use of cookies and similar technologies is governed by the Cookie Policy [bikinilovers.it/cookie-policy] and by the preferences made available in the Service.

Any marketing communications are sent only in accordance with the legal bases, choices and methods provided for by applicable law and by the notices made available to the User.

10. Reports and Protection of Rights

To report unlawful content, infringements of rights, security issues or abuse, the User may contact info@bikinilovers.it, providing the information necessary to enable a reasonable assessment.

The Operator reviews reports in accordance with its internal procedures and applicable law and may request further information to verify them.

11. Suspension and Termination of Access

The Operator may limit or suspend access to the Service where necessary for security, maintenance, legal obligations, the protection of third-party rights, fraud prevention or serious or repeated breaches of these Terms.

Where appropriate and reasonably possible, the Operator will inform the User of the measure taken and the available methods for seeking clarification or challenging its application.

12. Changes to the Terms

The Operator may amend these Terms for legal, technical, security, organisational or Service-development reasons. The new version takes effect from the date indicated at bikinilovers.it/terms-and-conditions.

If a change materially affects an ongoing relationship, the Operator shall adopt the communication methods and safeguards required by applicable law or by the specific contract.

13. Governing Law and Jurisdiction

These Terms are governed by Italian law, without prejudice to the mandatory rights granted to the User by the law applicable in their place of habitual residence.

For disputes involving a Consumer, jurisdiction lies with the court identified by applicable mandatory rules. For disputes with users acting in the course of a professional, commercial, artisanal or business activity, the court of Naples shall have jurisdiction, unless otherwise required by mandatory law.

14. Final Provisions

The invalidity or ineffectiveness of an individual clause shall not affect the validity of the remaining provisions. Any failure to exercise a right shall not constitute a waiver of that right.

For sales features, the Terms and Conditions of Sale [bikinilovers.it/conditions-of-sale] made available before the purchase shall also apply.
